A person who is aggrieved by a decision, requirement or determination of the Drainage Authority under section 18, 20 (1), 21 (1), 26 or 27 of the Ordinance may submit a notice of appeal to the Drainage Appeal Board in Form LDO 1 within 21 days after notification of such decision, requirement or determination.
- 2. This form shall be completed in accordance with the directions specified in the form.
- 3. The grounds of appeal shall be set out clearly in this form.
- 4. A copy of the notice or the notification appealed against shall be attached to this form.
- 5. The details and particulars, if any, specified in paragraphs 9 and 10 shall be sufficient to ensure that the Drainage Appeal Board and the Drainage Authority are fully informed of the grounds of appeal.
- 6. The completed notice of appeal shall be sent to the Secretary, Drainage Appeal Board Panel at 17/F, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong (or the latest address shown in its website: http://www.info.gov.hk/cml/eng/cbc/a88.htm).
