

## **O&M Branch Service Provider List**

### **Condition Surveys**

#### **Scope**

The service provider listed under this type of works is to carry out condition surveys for pipes, rising mains, box culverts, decked nullahs, drainage chambers, drainage channels, etc. not exceeding the quotation limit for services for construction and engineering works stipulated under Stores and Procurement Regulations (SPR) 220(b).

The scope of this type of works covers the design, supply and operation of equipment, implementation of works and providing reports for condition surveys of drainage and sewerage facilities, etc.

#### **Criteria for Admission to this Category**

The minimum admission criteria are as follows :-

1. A registered company in Hong Kong,
2. 3-year relevant local working experience of the company and key personnel of the company, and
3. Relevant job reference of 3 or more jobs in condition surveys each with a contract value of HK\$ 500,000 or more in the past 5 years.

#### **Criteria for Suspension and Removal**

The service provider will be suspended from bidding for quotation contracts of this type of works if he receives 2 reports with overall performance rated “poor” or “very poor” for the same quotation contract of this type of works due to poor performance within a 12-month period. The service provider’s name may also be removed from the central list if the third “poor” or “very poor” report of the same quotation contract of this type of works is issued. The service provider’s name will be suspended or deleted immediately from the central list if he performs poorly on the works on safety and environmental protection, misconduct or suspected misconduct, winding-up, bankruptcy or other financial problems, or failure or refusal to implement an accepted quotation.

For the service provider on the “List of Approved Contractors for Public Works” or “List of Approved Suppliers of Materials and Specialist Contractors for Public Works”, any regulating action as supported by a full written report will be forwarded to the Managing Department of the said lists and Development Bureau for follow-up actions as appropriate.

### **Replacement and Rehabilitation (R&R) Works**

#### **Scope**

The service provider listed under this type of works is to carry out replacement and rehabilitation to existing pipes, rising mains, box culverts, decked nullahs, drainage chambers, etc. not exceeding the quotation limit for services for construction and engineering works stipulated under Stores and Procurement Regulations (SPR) 220(b).

The scope of this type of works covers the design, supply and operation of equipment, supply of materials, implementation of works and providing reports for completion of the R&R works, etc.

#### **Criteria for Admission to this Category**

The minimum admission criteria are as follows :-

1. A registered company in Hong Kong,
2. 3-year relevant local working experience of the company and key personnel of the company, and
3. Relevant job reference of 2 or more jobs in R&R works each with a total length of rehabilitation works not less than 50m in the past 5 years.

#### **Criteria for Suspension and Deletion**

The service provider will be suspended from bidding for quotation contracts of this type of works if he receives 2 reports with overall performance rated “poor” or “very poor” for the same quotation contract of this type of works due to poor performance within a 12-month period. The service provider’s name may also be removed from the central list if the third “poor” or “very poor” report of the same quotation contract of this type of works is issued. The service provider’s name will be suspended or deleted immediately from the central list if he performs poorly on the works on safety and environmental protection, misconduct or suspected misconduct, winding-up, bankruptcy or other financial problems, or failure or refusal to implement an accepted quotation.

For the service provider on the “List of Approved Contractors for Public Works” or “List of Approved Suppliers of Materials and Specialist Contractors for Public Works”, any regulating action as supported by a full written report will be forwarded to the Managing Department of the said lists and Development Bureau for follow-up actions as appropriate.

### **Desilting Works**

#### **Scope**

The service provider listed under this type of works is to carry out desilting works to existing pipes, rising mains, box culverts, decked nullahs, drainage chambers, drainage channels, etc. not exceeding the quotation limit for services for construction and engineering works stipulated under Stores and Procurement Regulations (SPR) 220(b).

The scope of this type of works covers the design, supply and operation of equipment, implementation of works, disposal of silt and providing reports for completion of the desilting works, etc.

#### **Criteria for Admission to this Category**

The minimum admission criteria are as follows:

1. A registered company in Hong Kong,
2. 3-year relevant local working experience of the company and key personnel of the company, and
3. Relevant job reference of 2 or more jobs each with a total weight of desilted materials not less than 500 tonnes in the past 5 years.

#### **Criteria for Suspension and Deletion**

The service provider will be suspended from bidding for quotation contracts of this type of works if he receives 2 reports with overall performance rated “poor” or “very poor” for the same quotation contract of this type of works due to poor performance within a 12-month period. The service provider’s name may also be removed from the central list if the third “poor” or “very poor” report of the same quotation contract of this type of works is issued. The service provider’s name will be suspended or deleted immediately from the central list if he performs poorly on the works on safety and environmental protection, misconduct or suspected misconduct, winding-up, bankruptcy or other financial problems, or failure or refusal to implement an accepted quotation.

For the service provider on the “List of Approved Contractors for Public Works” or “List of Approved Suppliers of Materials and Specialist Contractors for Public Works”, any regulating action as supported by a full written report will be forwarded to the Managing Department of the said lists and Development Bureau for follow-up actions as appropriate.
