#### 丁、申請須知

1. 本署將於收到申請後 14 個工作天內回覆。申請表格內提交之資料如有不全或錯漏，本署可要求申請人提供補充資料以符合本申請表格內之要求。申請人應盡快根據本署要求回覆，重新遞交文件，以完成申請程序。
2. 請依照本署回覆所示，在限期前繳付相應的排放許可按金以完成申請程序。按金需維持在大約相等於申請者排放費繳款單的平均收費，本署將根據實際排放量，按時調整需繳付之按金，而該按金將於取消排放許可後退還。
3. 住宅流質廢物排放許可有效期會由發出日期起至該財政年度\*的最後一天，每年需申請續期。申請續期時段為每年二月一日至三月二十日，排放許可續期有效期為下一個財政年度\*的第一天至最後一天。  
排放許可新申請如於每年三月一日至三月三十一日提交，成功批核後、排放許可有效期為下一個財政年度\*的第一天至最後一天。

#### 5. 吸缸車規格：

請確保所有處理住宅流質廢物之吸缸都有裝置水鏡在當眼位置，並保持水鏡乾淨清晰，以便本署值班職員觀察吸缸內的住宅流質廢物水位和對吸缸內的廢物進行目視檢查。如吸缸劃分成不同部分獨立運作或吸缸車擁有兩個或以上的吸缸，所有吸缸或吸缸部分均需符合本條文之要求。

(水鏡是安裝在吸缸外的一條透明管，讓吸缸內的廢物流入水鏡內進行目視檢查。)

6. 本署可要求申請之吸缸車到指定的渠務署廠房進行檢查及各種測試。

## **APPLICATION NOTES**

### **A. Personal Data**

#### **Purposes of Collection**

1. The personal data provided by means of this form will be used by the Drainage Services Department (DSD) for the following purposes:
  - (a) activities relating to the processing of your submission in this form;
  - (b) activities relating to the above administration of the Domestic Liquid Waste Disposal Permission;
  - (c) statistical and any other legitimate purposes; and
  - (d) facilitating communication between DSD and yourself.
2. It is obligatory for you to provide the information as required in the form. If you fail to provide the required information, delay may be caused in processing of your submission or even result in rejection of the application.

#### **Classes of Transferees**

3. The personal data you provided by means of this form may be disclosed to other government departments, bureaux, organisations or any persons for the purposes mentioned in paragraph 1 above.

#### **Access to Personal Data**

4. You have the right of access and correction with respect to the personal data as provided under the Personal Data (Privacy) Ordinance. Request for personal data access and correction should be addressed to the Sewage Treatment Division 1 of DSD.

### **B. Completion of Form**

1. Please ensure that all relevant parts of the form are duly completed, and the form is signed. Please enclose all supporting documents. If more space is needed in this form, please use additional sheets and attach them to this form.
2. If incomplete or erroneous information is provided in the form, the Drainage Services Department may not be able to process the submission.

### **C. Submission Methods**

1. By Post / In Person - This form together with the copies of the supporting and relevant documents shall be posted to or submitted in person to the Sewage Treatment Division 1 of DSD. For postal application, the receive date by DSD will be regarded as the date of application.

Notes: Only e-Signatures issued by Hong Kong Post and DigiSign are accepted. Both personal certificates and organizational certificates are accepted. Inputted data items will be protected by e-Signature. After signing the PDF form, the form input will be read-only.

#### D. Application Guide

1. DSD will reply to the applicant within 14 working days upon receipt of the application. DSD may request the applicant to submit relevant supplementary documents to satisfy the requirement of all the items in this form for incomplete or erroneous information provided. Applicant should resubmit the required documents as soon as possible to complete the application process.
2. Please follow instructions stated in the reply letter to settle the payment deposit by the payment deadline for completing the application. The deposit shall maintain at about the average DLW disposal charge of each Demand Note of the applicant. DSD will adjust the required deposit from time to time according to the actual disposal volume. The deposit will be returned after the permission is cancelled.
3. The validity period of Domestic Liquid Waste Disposal Permission is from the date of issue to the last day of the financial year\*. Renewal is required for every year. The renewal period is 1 February to 20 March of every year. The renewed permission is valid from the first day to the last day of the next financial year\*

For new applications received in the period 1 March to 31 March every year, their disposal permission will be effective from the first day to the last day of the next financial year\* if approved.

5. Please make sure all the tanks for handling domestic liquid waste have installed their own water meter and prominently displayed. The water meters shall be kept clean and clear to allow DSD plant staff to observe the water level of the tank and carry out visual inspection of the waste. If the tank is divided into different separate functional sections/partitions or the tanker have two or more tanks, all sections and all tanks involved must fulfill all requirements mentioned above. (Water meter is a transparent tube installed at outside of a tank. Waste inside the tank shall flow into the water meter for visual inspection.)
6. DSD may request the applied tanker for inspection and various tests at designated plant of DSD.
