

參加者須知

Application Guidance Notes

1. 參觀前注意事項:

- 導賞團全程需步行約1小時,部分路段斜度較大,需要一定的體力完成。 申請者於申請時應衡量其實際身體狀況,考慮是否適合參加該導賞團及 需要由照料者陪同和協助參加導賞團。
- 参加者有責任確保活動當日自身健康狀況良好,如有任何身體不適,不宜 參與活動。
- 本署職員會於集合地點量度參加者的體温,如體温高於攝氏 37.5 度,本署職員有權拒絕其參與活動。

Points to note before the visit:

- The guided tour takes a walk of about 1 hour. Sections of the route are steep and certain efforts will be required. Applicants should assess their own health conditions and consider whether it is necessary to be accompanied and assisted by care takers before making application for the guided tour.
- Participants are responsible to ensure that their health conditions are good on the date of visit. If there is any discomfort, it is not recommended to participate in the visit.
- Our staff will measure the body temperature of the participants at the assembly point. If the body temperature of a participant is higher than 37.5°C, our staff may reject his/her participation in the visit.

2. 参加者個人裝備建議:

- 穿著合適衣服及運動鞋
- 防疫用品(包括後備口罩、搓手液、消毒濕紙巾等)
- 防蚊用品(例如:蚊怕水)

Recommended participants' equipment:

- Please wear suitable clothes and sport shoes.
- Anti-epidemic supplies (including back-up face masks, hand sanitizer and disinfectant wet tissues)
- Anti-mosquito products (such as mosquito repellent)

3. 參觀期間注意事項:

- 參觀活動期間須聽從導賞員指示。切勿進入任何不被允許進入的範圍,免 生危險。
- 參加者於活動舉行期間須注意安全及小心保管個人財物。
- 参加者於參觀期間須全程佩戴口罩,並避免在參觀期間飲食(補充水分及 服用藥品除外)。



● 参加者於參觀期間必須保持良好個人衞生及適當社交距離。

Points to note during the visit:

- Please follow the tour guide's instructions during the visit and do not enter any restricted areas to stay safe.
- Participants should pay attention to their own safety and take care of their personal belongings during the visit.
- Participants are requested to wear face mask at all times and avoid drinking or eating throughout the visit (except drinking water and taking medicines).
- Participants are reminded to maintain good personal hygiene and appropriate social distancing throughout the visit.
- 4. 若 3 號或以上熱帶氣旋警告信號;或紅色或以上暴雨警告信號於參觀活動開始前 3 小時內仍然生效,當天的參觀活動將會自動取消。

The visit will be cancelled automatically if Tropical Cyclone Warning Signal No. 3 or above; or Red Rainstorm Warning Signal or above is in force within 3 hours before the visit is scheduled to begin.

防疫措施

Disease Precautionary Measures

5. 所有參觀渠務署設施的人士必須填寫並簽署健康申報表,並於集合地點備妥 已填寫及簽署的健康申報表,以供收集。如參觀人士未能填妥健康申報表或 確認健康申報表所列出的事項,有關參觀人士將不能參加活動。

All visitors visiting DSD facilities must sign and complete the Health Declaration Form, and the completed and signed Health Declaration Form should be ready for collection at the assembly point. Visitor will not be allowed to join the guided tour if he/she does not comply with the above.

6. 參觀人士如正在接受政府指定的強制檢疫(包括「居安抗疫計劃」及家居隔離)或在等候進行最後一次冠狀病毒病強制檢測或在等候最後一次冠狀病毒病強制檢測的檢測結果或在過去 14 日內曾離開香港或曾與任何懷疑、疑似或確診感染 2019 冠狀病毒的人士有緊密接觸(緊密接觸可指(其中包括):有直接身體接觸、一同居住、有近距離社交接觸。),將不能參加活動。

Visitors who are undergoing government-designated compulsory quarantine (including "StayHomeSafe Scheme" and home quarantine) or are waiting for the last mandatory COVID-19 test or the test results of the last mandatory COVID-19 test or who have been out of Hong Kong



or have been in close contact (close contact could mean (among other things): having direct physical contact, living in the same household, having social contact in close proximity.) with any person with a suspected, probable or confirmed case of COVID-19 in the past 14 days, will not be allowed to join the guided tour.

7. 參觀人士需在參觀活動當日完成快速抗原測試,並獲得陰性結果,才能參與 本活動。

Visitors are required to undergo a rapid antigen test on the day of the visit and obtain a negative result before joining the guide tour.

8. 所有參加者(12 歲以下和 65 歲或以上的人士除外)須全程隨身攜帶已安裝「安心出行」流動應用程式的智能手機,並在集合地點掃描二維碼以作紀錄。

All participants (except for participants who are aged below 12 or aged 65 or above) are required to bring with them a smartphone having installed the "LeaveHomeSafe" mobile application throughout the visit and are required to scan the "LeaveHomeSafe" QR code at the assembly point.

9. 所有參加者均須滿足「疫苗通行證」下當時適用的要求接種 2019 冠狀病毒病疫苗,持有有效醫生證明書證明其因健康原因不適宜接種 2019 冠狀病毒病疫苗的參加者除外。「疫苗通行證」的詳情,請參閱 2019 政府冠狀病毒病專題網站。本署職員會在集合點檢查參加者的疫苗接種記錄,一旦發現參加者未能滿足「疫苗通行證」下當時適用的要求,本署職員將拒絕其參與活動。

All participants are required to fulfill the prevailing Vaccine Pass requirements to receive COVID-19 vaccine(s) unless he/she is holding a valid medical certificate stating that he/she is unfit, on medical ground, to be administered with a COVID-19 vaccine. For details of the Vaccine Pass requirements, please visit the COVID-19 Thematic Website. Our staff will check the vaccination records of the participants at the assembly point. Once it is found that the prevailing Vaccine Pass requirements cannot be fulfilled, our staff will reject his/her participation in the visit.
